Course Description: Students will learn to explore basic linguistic concepts including phonology, morphology, syntax, pragmatics and semantics. This course will also focus on how a language is organized and functions, and will establish a connection between Linguistics and Translation Theory. It also addresses current trends in Traductology as a basis for understanding Interpretation as a process, and its implications in interpreters' performance. (3 hr. lecture)

FOT2992 Introduction to Medical Interpreting Skills

Course Description: Students will learn the techniques, practices and knowledge needed to function as interpreters in a medical environment. Interpreting modes such as sight, consecutive and simultaneous – as they apply to the medical setting – are revisited. Though this is a language neutral skills course, simulations will be conducted in the working languages of the participants whenever possible. (3 hr. lecture)
