

ARTICULATION AGREEMENT BETWEEN

C. W. POST CAMPUS OF LONG ISLAND UNIVERSITY

AND

MIAMI-DADE COMMUNITY COLLEGE

C. W. Post Campus of Long Island University and Miami-Dade Community College (M-DCC) hereby enter into the following articulation agreement governing the matriculation of Associate of Arts graduates from M-DCC at C. W. Post Campus of Long Island University beginning in the Winter term of 1995 and continuing for a period of four years, after which both institutions will undertake renegotiations of the agreement.

For Miami-Dade Community College A.A. graduates admitted to the C. W. Post Campus of Long Island University, during the period of this agreement, the C. W. Post Campus of Long Island University will:

- 1 accept the students as having junior standing, with the understanding that some students may need to complete prerequisite work for programs in which they enroll;
- 2) accept the 36 required general education credits earned at M-DCC, including those within the interdisciplinary core curriculum, applying them toward the equivalent lower division, general education requirements of the university.

During the period of this agreement, Miami-Dade Community College will:

- 1 publicize the agreement among its students and faculty;
- 2) make available to students through the Advisement Office and Career and Transfer Centers, a description of the recommended Associate in Arts (A.A.) curriculum for all Long Island University majors;
- 3 review the performance of the M-DCC graduates who matriculate at C. W. Post Campus of Long Island University in each of the academic programs, assessing the students' academic preparation and the success of the general education core courses.

During the period of this agreement, both institutions agree:

- 1) to monitor the academic performance of students enrolling under the agreement, identify problems, and work cooperatively to adjust details of course sequences and content so that students can transfer without academic disruption;
- 2) to arrange articulation meetings to develop major course equivalencies between C. W. Post Campus of Long Island University and M-DCC; and
- 3 to notify each other concerning any contemplated curricular changes which would affect the future of this agreement.


**SCHOLARSHIP AGREEMENT BETWEEN**

**Miami-Dade Scholarships**

The following outlines the terms and procedures, acceptable to both Miami-Dade Community College and the C.W. Post Campus of Long Island University, pertinent to the Miami-Dade Scholarships for graduates of Miami-Dade Community College.


1. C.W. Post will offer to qualified graduates of Miami-Dade Community College scholarships that range from \$3,000 to \$10,000 per year.
2. The candidates for these scholarships must have a final cumulative average of 3.25 or better.
3. Scholarship amounts will be based on a candidates cumulative GPA.
4. The candidates must be earning an Associate Degree (A.A.) at Miami-Dade Community College in any major.
5. Candidates will be recommended by a delegate of Miami-Dade Community College (determined by the President of Miami-Dade), and winners will be selected by the C.W. Post Provost's Scholarship Committee.
6. Names of candidates must be submitted to the Provost of C.W. Post by July 1 of each year.
7. The winners must attend C.W. Post on a full-time basis.
8. The winners must transfer directly from Miami-Dade Community College to C.W. Post, attending no other college in between. They may, however, "stop out" for one year, but no more than two years after graduating from Miami-Dade Community College.
9. The terms and procedures of these scholarships will be reviewed periodically by both institutions.

We hereby endorse this agreement, as specified herein.
