## HSC2400 | Basic Emergency Care | 3.00 credits

Designed to provide opportunities to develop, practice, and display skills concerning emergency care and the prevention of accidents. This course meets the American Heart Association Healthcare Provider Cardiopulmonary Resuscitation/Automated External Defibrillation and the American Red Cross for Standard First Aid Certification requirement.   - Heatstroke
- Demonstrating first aid for heat cramps, heat exhaustion, and heatstroke.
- Describing how to determine the apparent temperature.
- Demonstrating how to determine the apparent temperature.

- Demonstrating the first aid for one of the above listed situations as appropriate.
- Demonstrating how to move victims in emergency and non-emergency situations using:
  - o One-person moves
  - Two-or three-person moves
