# **MDC's QEP Operational Outcomes**

- Instructors will teach writing as a process that includes brainstorming, drafting, revising, editing and proofreading.
- Instructors will teach students to locate, evaluate, manage and synthesize information.
- College employees will work together to organize career-related co-curricular events and activities to be embedded in the curriculum with a written component.
- Instructors will design a portfolio project or capstone course that requires students to reflect, in writing, upon their work.

### **MDC's QEP Strategies**

- Implement curriculum changes in QEP-related courses.
- Expand co-curricular opportunities that enhance students' writing skills and career knowledge.
- Build capacity of campus academic support.
- Design and implement a professional development program that provides training for faculty, staff and tutors while focusing on high-impact practices that emphasize career-specific writing growth.



#### What is a QEP?

The QEP (Quality Enhancement Plan) is a five-year action and implementation plan that will enhance student learning and further strengthen MDC's educational model.

The Southern Association of Colleges and Schools (SACS) notes that "developing a QEP as a part of the reaffirmation process is an opportunity for the institution to enhance overall institution quality and effectiveness on an issue or issues the institution considers important to improving student learning."

# Why Are We Creating a QEP?

Every 10 years, all regionally accredited colleges and universities engage in the renewal of their institution's accreditation. A major part of the reaffirmation process is the development and submission of a QEP to SACSCOC.

Miami Dade College is accredited by the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC) and is scheduled for reaffirmation in 2015.

#### **MDC's QEP**

Miami Dade College's QEP is "Writing for the Real World: Strengthening Writing and Career Knowledge." With the motto of *Do The* Write Thing, MDC's QEP is designed to enhance the existing high quality of education that students and graduates receive at MDC.
