Identifying the limitations imposed by law at the local levels. 4. Exploring current trends and special programs. 	
<p>Competency 6: The student will demonstrate knowledge of state police and highway patrol organizations by:</p>

Comparing and contrasting the mission statement of the state agencies. 3. Identifying the limitations imposed by law on the state agencies. 4. Exploring current trends and special programs. 	
<p>Course Competency 7: The student will identify and discuss the various functions and responsibilities of federal law enforcement agencies by:</p>	
<ol style="list-style-type: none"> 1. Citing and describing the agencies that make up the federal system. 2. Analyzing the reorganization of these agencies as a result of homeland security concerns. 3. Recognizing the evolving mission of the federal agencies. 4. Exploring current trends and special programs. 	
<p>Course Competency 8: The student will demonstrate knowledge of private security agencies by:</p>	

<ol style="list-style-type: none"> 1. Citing and describing the types of agencies that comprise the private security sector. 2. Analyzing how private security interacts with public agencies. 3. Recognizing the limitations as imposed by law. 4. Exploring current trends and special problems. 	
<p>Course Competency 9: The student will demonstrate knowledge of the internal organization of law enforcement agencies by:</p>	
<ol style="list-style-type: none"> 1. Comparing and contrasting the chains of command and their impact on organizational structures and efficiency. 2. Analyzing specialized units and their missions and functions. 3. Debating succession plans. 4. Listing and describing unions for law enforcement and the collective bargaining process and its impact on law enforcement.

Identifying the roles of law enforcements in local government hierarchy. 3. Analyzing the interrelationship between law enforcement and the political structure. 4. Analyzing the interrelationship between law enforcement and the political structure. 5. Identifying the impact of budgets on law enforcement organizations.
