

Course Description

PLA2227 |Civil Law and Litigation | 3.00 credits

This course will introduce students to a comprehensive exploration of civil procedure, pleadings, evidence, motions, damages, appeals, and alternative dispute resolution. Students will gain skills in the application of law when preparing documents before, during, and post-trial. A minimum of a "C" is required to pass this course. Prerequisites: ENC1101, PLA2003, PLA2120C, and PLA2931

Course Competencies:

- 1. Recognizing the importance of law office procedures in law practice
- 2. Explaining the ethical obligations of the paralegal in the legal arena

- 4. Defining the term statute of limitation and identifying its significance in the litigation process

- 4. Identifying the different types of evidence
- 5. Determining the sources of information that will assist in proving the elements of a client's case
- 6. Describing techniques for gathering discovery and evidence and learning to preserve the evidence in preparation for trial
- 7. Utilizing the Florida Rules of Civil Procedure in preparing various pleadings and motions

- 4. Drafting a complaint and delineating its components
- 5. Identifying the different types of motions to dismiss under Federal Rule 12(b)
- 6. Understanding the purpose of removing a state action to federal action
- 7. Drafting an answer, affirmative defenses, counterclaim, and cross-claim
- 8. Distinguish between amending and supplementing pleadings
- 9. Preparing various responsive motions, including motions for judgment on the pleadings and summary judgment

- 5. Drafting a default judgment for a state or federal case
